Dear Kids' Care and SOAR Parents,

We appreciate the opportunity to serve your children in our Kids Care and SOAR Programs. Your complete satisfaction with our programs is very important to us. We are sensitive to maintaining competitive pricing for our programs to best serve the families in our community.

The Fair Wage Act effective of 2016 requires a mandatory increase of minimum wages as outlined in the California Labor Code. The impact of this requirement will increase our staff wages for the coming year by 9%. As a licensed program through the State of California, we are required to maintain student to staff ratios of 14:1. To address these changes we will need to raise our program prices. The price increase ranges from 0-6% and is effective for the 2018-19 school year.

This price increase is necessary to continue to provide your child with the quality program you've come to expect. If you have any questions or concerns, please don't hesitate to contact me.
